## The Tucson Airport Authority

The Tucson Airport Authority (TAA) was established on April 12, 1948, as a civic, non-profit corporation as provided for under Arizona law. Composed of residents of Tucson International Airport's service area, the Authority was created to develop, promote, operate, and maintain airports and air transportation facilities. TAA manages the operation of Tucson International Airport and Ryan Airfield, a general aviation field 12 miles west of Tucson International Airport.

TAA does not receive any local tax dollars. Operations are funded through revenues from parking, space rentals, land leases, fuel sales, airline landing fees, and concessions. Capital improvements are funded through state and federal grants.

On October 14, 1948, the City of Tucson and the Authority entered into a lease to manage airport facilities. The lease, which continues until October 14, 2073, with the ability to extend until 2098, provides that the Authority has the obligation to operate, maintain and develop the airport as a public facility for the accommodation of air commerce.

## Our Mission

The mission of the Tucson Airport Authority is to promote aviation and foster economic development by strategically planning, developing and operating the most effective, efficient and safest airport system for southern Arizona.
